Focus on opportunities

Museums and Cultural Institution

I have had the privilege of working with some of the world's most esteemed museums and cultural centers, including the Whitney Museum, the Smithsonian Institution, the George Eastman Museum, the San Francisco Museum of Modern Art and the Corning Museum of Glass. I advise on acquisitions, dispositions and other aspects of collection management, and help clients navigate issues concerning copyright permissions, registration and licensing, as well as the fair-use doctrine. Some examples of experience include:

- Successfully represented The San Francisco Museum of Modern Art (SFMOMA) in the historic SFMOMA-Fisher Agreement. Nixon Peabody attorneys served as counsel and advisors to the parties to craft the unprecedented agreement to showcase the renowned 1,100 piece Fisher Collection of modern and contemporary artwork. The work involved working with the collectors' family and foundation, as well as a major arts institution in order to structure a comprehensive agreement which ensures the public enjoyment of the collection for decades to come.
- A private operating foundation sought counsel on the creation of a separate museum entity to occupy the last remaining piece of undeveloped real estate on Pennsylvania Avenue. We worked with the charity to structure the acquisition of the parcel, financing of construction and planning for residences

and signature restaurant facilities for the newest and most exciting museum in Washington, D.C.

Industry involvement is vital to comprehensively understanding the issues museums, libraries and other cultural institutions face, so I also regularly participate in national programs and conferences, leading discussions such as the American Law Institute's CLE program, "Legal Issues in Museum Administration."

Tax benefits

Charitable institutions and their donors have an array of tax benefits available to help advance their mission. We understand those incentives and advise on how to increase their impact. Close attention to even long-held tax benefits is a necessity in today's political environment.

Governance and Risk Management

Good governance is vital to operations and fashion approaches that make the most of precious volunteer time and resources. That includes the use of multicorporate environments and joint ventures to accomplish exempt purposes. At the same time, we appreciate that success involves a degree of risk, so that when challenges arise our work involves the identification of a plan and resources necessary to continue the focus on success. In the highly regulated environment in which our clients exist, it is essential to be able to marshal such resources quickly and efficiently.

What do you see on the horizon?

The capacity of our nonprofit institutions to provide needed services and perspectives is being fundamentally challenged by economic forces and an increasingly hostile regulatory environment. Success will be rooted in new collaborations and new partners, drawing on the best practices of the business and governmental sectors, but making them our own.
